The undergraduate University Curriculum Committee, comprised of faculty from varied college/schools, is the responsible party for ongoing evaluation of the core curriculum and for providing guidance to the Administration for curricular composition and modification, such as program and course creation, change, and deletion.

The committee's voting members were Becky Hotovy, Dr.Lance Johnson, Dr. Evangeline Rukundo, and Nancy Christensen (chair). The non-voting members were Eric Maczka, University Registrar and Institutional Researcher, Kate McCown, Director of Academic Core Experience, and Rachel Wachter, Director of Student Success.

The following tasks were completed during the 2020-2021 academic school year:

#### I. Core Curriculum Assessment:

- During the 2019-2020 academic year, a <u>Google Form</u> was developed to collect DRIVE assessment data.
- The DRIVE framework launched with the 2020-2021 academic year, so fall 2020 was the first semester DRIVE assessment was collected.
- An additional "<u>DRIVE assessment COVID-related changes</u>" Google Form was created to capture information about any changes to course embedded assessments due to COVID (in DRIVE attributed courses).
- On September 23, 2020 the Director of Academic Core Experience hosted a DRIVE assessment session for faculty to reinforce the DRIVE assessment process and to answer any remaining questions. The live session was recorded and the recording was shared with faculty via the Faculty Resource Canvas course.
- At the conclusion of the fall 2020 semester, a total of 81 courses were assessed
